Twenty Under 40!: Edmond J. Mack

He has been named a five-time "super lawyer" and is serving his second term on Canton City Council.

Those are only a few of Edmond J. Mack's accomplishments. Now the 32-year-old Mack can add the honor Twenty Under 40! to the list.

"I was humbled, honored that my efforts that I've been devoting to the area were recognized in such an honor and I'm proud," he said.

Mack and his wife, Andrea, are the parents of Isabella. He works as an attorney for the local firm Tzangas Plakas Mannos. Mack volunteers on the Stark County District Library Board and has volunteered his services to the Wills for Heroes Foundation, which provides free legal documents to first responders.

Mack graduated from Minerva High School and earned a bachelor's degree from Kent State University, where he serves on the Stark chapter's alumni board. He earned his law degree with a certificate in litigation from the University of Akron School of Law.

"I try to give back to the community any way I can," Mack said, "whether it's service on Canton City Council or service on a board or volunteering at different events. Giving back to Stark County by volunteering your time and talent ... is something that any young professional should do."

Mack, who has represented the city's 8th Ward since 2012, serves as chairman of council's judiciary committee. He has been an advocate for downtown development and believes a strong city center and park system can help attract and retain young people like himself.

"I'm committed to trying to reverse the brain drain, not just by words, but my actions," he said. "That's why I work in the city, live in the city and serve the city. If we want to have a successful community we have to do everything in our power, to combat brain drain. The best way to do that is to lead by example."
